Informed Consent Verbal Script Southern Wesleyan University Institutional Review Board

The IRB may approve a verbal/oral script as an alternative to the written form in research that is determined to involve minimal risk. The script must include the general requirements of informed consent and be submitted to the IRB for review and approval prior to initiation of research.

The informed consent process should be appropriate to the research and participant population being studied.

The script should include the following elements:

- 1. Description of the research and investigators conducting the research;
- 2. Explanation of the procedures (e.g., audio/video recording);
- 3. Duration of the subject's participation;
- 4. Subject protections (e.g., extent to which confidentiality will be maintained);
- 5. Permission to begin the research;
- 6. If feasible, the participant should be given the contact information of the investigator (e.g., business card, copy of the script with contact information listed).
